

**SWEEPSTAKES OFFICIAL RULES**

**ELIGIBILITY:** Each Sweepstake is only open to legal residents of the 50 States of the United States, the District of Columbia and any US Territory age 16 or older at the time of entry, and who meet one (1) of the four (4) following eligibility requirements at the time of entry: 1) a parent or guardian who currently has a student enrolled in an accredited college or university located within the United States; 2) a student who is currently enrolled in an accredited college or university located within the United States; 3) a parent or guardian who has a student currently enrolled as a senior or junior in a high school located within the United States and such student intends to enroll in an accredited college or university located in the United States within one year of graduating high school; 4) a student who is currently enrolled as a senior or junior in a high school located within the United States and who intends to enroll in an accredited college or university located with the United States, within a year of graduating high school (each an “Entrant”).

Employees of SLM Education Services, LLC (the “Sponsor”) and its parents, members, agencies, affiliates, and subsidiaries, and their immediate family members (spouse, parents, children, and siblings, and their respective spouses) and persons living in the household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void outside the U.S. and wherever prohibited by law.

**ENTRY:** There is one (1) method of entry.

**Method:** Online Entry: Participants may enter by visiting a Sallie approved Scholly Scholarship entry form via [sallie.com/scholarships](http://sallie.com/scholarships), completing the online entry form and submitting the form to receive one (1) Sweepstakes Entry (the “Entry”) per Sweepstakes per Entry Period. Participants may also enter multiple sweepstakes per Entry Period by using the [Scholly Easy Apply Scholarships](#) Form which will list all available sweepstakes. Use of the Scholly Easy Apply Scholarships Form shall result in and be deemed one (1) Entry per each available Sweepstakes listed in the Scholly Easy Apply Scholarships Form for that Entry Period. Applicants using the Scholly Easy Apply Scholarships Form are eligible to win one or more Sweepstakes listed on the Form for each application and Entry Period; however, each Sweepstake may only have one (1) winner. Entries must be received within the date and time listed for each Sweepstake and its corresponding Entry Period. **Limit:** One (1) Entry per Sweepstake, per Entry Period and per email address.

**ENTRY PERIOD CONSIDERATIONS:** Entries must be received during the listed Entry Period to be eligible for and entered into that Sweepstakes. Non-winning entries, entries not received within the applicable Sweepstakes Entry Period or otherwise ineligible entries will not be rolled over to subsequent Sweepstakes in subsequent Entry Periods.

**RANDOM DRAWING:** One (1) Grand Prize winner for each Sweepstake per applicable Entry Period will be selected in a random drawing from among all eligible Entries received for

that Entry Period. All decisions are final and binding in all matters related to these Sweepstakes.

**WINNER NOTIFICATION, VERIFICATION AND DISQUALIFICATION:**

**Notification of Winner:** The potential Grand Prize winner will be notified via email and/or phone, within thirty (30) days of the selection of a winner. Except where prohibited by law, the potential Grand Prize Winner will not be deemed a Grand Prize winner until receipt of the Releases, clearance of a background check, and confirmation that they are in compliance with these Official Rules. In the event that a potential Grand Prize winner is disqualified from the Sweepstakes or otherwise does not accept the Grand Prize, the Sponsor may choose one (1) alternate winner.

**Releases.** Except where prohibited by law, the potential Grand Prize winner will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, and a Publicity Release (collectively, "the Releases"). These Releases will require, among other things, that the potential Grand Prize winner provide their social media handles and Social Security Number, as well as the name and information of the college or university in order to distribute the Grand Prize to the appropriate school. If the potential Grand Prize winner is a Parent, they must also provide such information about their student. Potential Grand Prize winners who are minors in their state of residence must have their Parent or Guardian execute the Releases.

The potential Grand Prize winner shall be disqualified and they shall no longer be eligible for and/or shall forfeit the entirety of any Sweepstakes Grand Prize if Releases are not returned or returned as undeliverable, if the potential Grand Prize winner cannot accept or receive the Grand Prize for any reason, if the potential Grand Prize winner is not in compliance with these Official Rules or if any of the disqualifying criteria listed in these Rules are applicable.

**Background Check:** Each potential Grand Prize winner consents and agrees to a background check to confirm eligibility and compliance with these Rules and to help ensure that the use and participation of any such person in the Sweepstakes and advertising or publicity for the Sweepstakes will not bring Sponsor into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Sweepstakes or Sponsor (collectively the "Reputation Risks"), as determined by Sponsor in its sole discretion. Sponsor reserves the right to disqualify a potential Grand Prize winner on the basis of the findings of any Reputation Risks from such background check or if a potential Grand Prize winner fails to properly authorize and/or provide the required information in connection with such background check. If the potential Grand Prize winner is a Parent then

no background check is required for the Parent but they must obtain consent from their student to have such background check performed on the student, and such background check shall be subject to the terms in this section.

**Proof of Enrollment:** The potential Grand Prize winner must submit proof of their or their student's current enrollment (at the time of submission of proof) in an accredited college or university located within the United States as follows:

For Grand Prize winners who are, or who have, a student who is a senior or junior at a high school located in the United States: within twelve (12) months of graduation from high school

For all other Grand Prize winners: within twelve (12) months of receipt of notice of Grand Prize.

Failure to provide proof of current enrollment within the time limits shall disqualify the potential Grand Prize winner and they shall no longer be eligible for and/or shall forfeit the Sweepstakes Grand Prize. Sponsor may select one (1) alternate winner

**Disbursement of Grand Prize:** The Grand Prize will be disbursed directly to the Grand Prize winner or their student's accredited college or university located in the United States. Sponsor is not responsible for the application or allocation of any Grand Prizes sent to such college or university. No Grand Prize nor any monetary amount shall be sent or payable directly to the Grand Prize winner or their student. Sponsor will work with winners to identify the time and place of disbursement.

**PRIZE/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:**

For each Sweepstake per Entry Period, there will be one (1) Grand Prize awarded, for an amount between \$500-\$5,000 as listed in the Table above. Odds of winning a prize will depend upon the total number of Entries received for each Sweepstake per Entry Period.

**PRIZE CONDITIONS:** The Grand Prize will be disbursed directly and only to the accredited college or university located in the United States as designated by the Grand Prize winner. The winner is responsible for all federal, state and local taxes, if applicable. Any other incidental expenses associated with the receipt and/or use of prize is the winner's sole responsibility. Except where prohibited by law, Entry and acceptance of a Grand Prize constitute permission to use winner's name, prize won, hometown, likeness, video tape, photographs, and statements for purposes of advertising, promotion and publicity

(including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission.

In the event of a dispute over the identity of an online Entrant, Entry will be deemed submitted by the "Authorized Account Holder" of the e-mail address submitted at time of entry. Authorized Account Holder means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Sponsor may ask any Entrant or potential Grand Prize winner to provide Sponsor with proof that such party is the authorized account holder of the e-mail address associated with the Entry. **DISPUTES:** Except where prohibited, Entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the state of Delaware. THE PARTIES HEREBY WAIVE THEIR RIGHT TO JURY TRIAL WITH RESPECT TO ALL CLAIMS AND ISSUES ARISING OUT OF OR RELATING TO THIS AGREEMENT WHETHER SOUNDING IN CONTRACT OR TORT, AND INCLUDING ANY CLAIM FOR FRAUDULENT INDUCEMENT THEREOF.
